Lifetime Warranty

What is Covered?

CGC Inc. warrants that when applied to a sound structure using recommended application techniques as described below and in EWB-5227 "SHEETROCK Brand Paper Faced Metal Drywall Trims... Installation Guide", SHEETROCK Brand Paper Faced Metal Tape On Trims will not edge crack for the lifetime of the structure. Inside offset corners applied horizontally cannot be guaranteed against cracking. An example would be the apex of a vaulted ceiling. This warranty also does not cover SHEETROCK Brand Paper Faced Metal Nail On Trims.

Recommended Application Techniques

- Make sure wallboard is clean, firm and dry before applying corner bead and trim.
- Make sure that the steel bead or trim is wide enough to cover any gaps in the wallboard.
- Leave a 6 mm gap between the bottom edge of the corner bead or trim and the floor.
- Apply a full layer of taping joint compound beneath the bead or trim paper and steel.
- Make sure that taping coat is completely dry before applying additional coats.

What Will CGC Inc. Do?

If edge cracking should occur, CGC Inc. will at its option replace the material or refund the purchase price.
